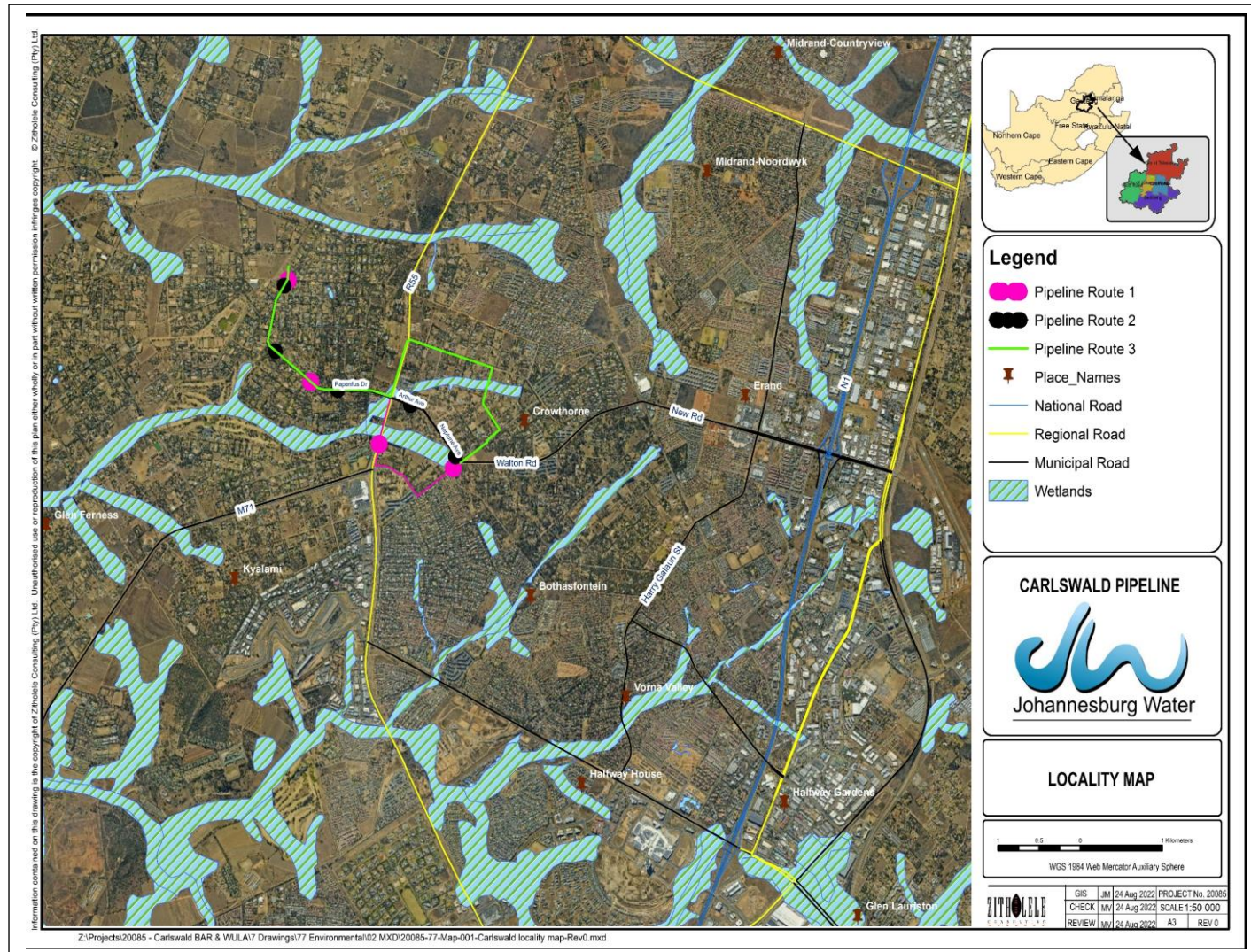


# Basic Assessment and Water Use License Application Process for the proposed upgrade of the water pipeline network in Carlswald, Gauteng Province

Notice is hereby given in terms of the National Environmental Management Act, No. 107 of 1998 (NEMA), Environmental Impact Assessment Regulations 2014, as amended (GN R.326), of Johannesburg Water's intention to upgrade water pipelines in Carlswald in the Gauteng Province.

### Nature of Proposed Activity

Johannesburg Water SOC Limited proposes to upgrade the water pipelines in Carlswald, which is situated in Gauteng Province. The Carlswald suburb is situated approximately 24km north of Johannesburg and falls within the jurisdiction of the City of Johannesburg Metropolitan Municipality. The proposed pipelines are approximately 5.1km in length, with diameters ranging between 125mm and 630mm.

### Location of Proposed Water Pipeline Replacement

The proposed water pipeline upgrade is located in Carlswald, Midrand, situated 7 km north-west of Halfway House. The site falls under the jurisdiction of the City of Johannesburg Metropolitan Municipality in the Gauteng Province.

### Legislative requirements

The upgrade of water pipelines will trigger several listed activities in terms of the EIA regulations, 2014 (as amended), Listing Notice 1 (GN R.327) and Listing Notice 3 (GN R.324), as amended. The proposed development will also trigger Section 21 (c) and (i) water uses in terms of the National Water Act, No.36 of 1998. A Basic Assessment process and Water Use License Application process will therefore be undertaken to authorise the proposed activities associated with the proposed development.
