

NOTIFICATION OF APPLICATION FOR ENVIRONMENTAL AUTHORISATION AND WATER USE AUTHORISATION PROCESSES FOR THE PROPOSED SPORTS FACILITY AND ASSOCIATED INFRASTRUCTURE AT THE NORTH WEST UNIVERSITY: MAHIKENG CAMPUS, ON THE REMAINDER OF ERF 1090 MMABATHO UNIT 5, NORTH WEST PROVINCE

Notice is hereby given that North West University (NWU) Mahikeng Campus (the Applicant) has applied for Environmental Authorisation (EA) for the above project. An EA is required by way of a Basic Assessment (BA) Process, from the Competent Authority, i.e. North West Department of Economic Development, Environment, Conservation and Tourism (NW EDEC&T) in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 (as amended), promulgated in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA). Zitholele Consulting (Pty) Ltd is the independent Environmental Assessment Practitioner (EAP) for the BA process.

The North West University (NWU) Mahikeng Campus plans to establish hockey and cricket sports facilities adjacent to the existing soccer and rugby sports fields at the Mahikeng Campus. Pavilions, change-rooms, club houses, parking areas, access roads on site and future sports fields are also planned. These sports facilities/fields will have grass fields with adequate irrigation and lighting.

In terms of Listing Notice 1 (GNR No. 327) of the EIA regulations, 2014 (as amended) the proposed development will trigger listed activities 19 and 27, and listed activities 12 and 14 of Listing Notice 3 (GNR No. 324).

The proposed sports facility and associated infrastructure occurs within the 100m regulated area of natural non-perennial drainage lines. Therefore, a Water Use Authorisation (WUA) will be required in terms of Section 21(c) and 21(i) of the National Water Act, 1998 (Act No. 36 of 1998) by the Department of Water and Sanitation (DWS).
